Take Part in the Youth Involvement Board's 2019 Scholarship Program at HEFCU!

HEFCU is taking part in the New Jersey Credit Union League's Youth Involvement Board's (YIB) 2019 statewide Scholarship program.

If you are a high school senior and a HEFCU member, you are eligible to apply!

The YIB scholarship is an award of up to \$1,000 to be paid jointly to the winning student and the student's chosen accredited educational institution. The applicant must be a member in good standing at HEFCU and must be enrolled as a high school senior at the time of the application. Scholarship funds must be used for tuition only at an accredited educational institution (Community college, 4-year college, university, or vocational/technical school).

The judging of the entries will be performed by YIB volunteers and is based on academic performance, extracurricular activities, community service/involvement, references, and leadership roles. The application deadline is March 29, 2019.

Don't Let Your Account Go To The State!

Did you know that if a checking or savings account remains inactive for three years, New Jersey state law requires that the funds in it be transferred to the State? HEFCU members will be notified on an annual basis if their account is subject to the New Jersey Escheat Law.

It's easy to safeguard your money! Help protect your account by simply making a deposit or withdrawal once during the three years or notifying us in writing that you acknowledge the existence of your HEFCU account. For more information on whether your funds (or a family member's funds) are being held by the State of New Jersey (or another state) visit www.unclaimed.org today.
